

**PRESENTATION OF NEW BUSINESS LOCATED AT 398 MAIN STREET**



Some church pastors in attendance made comments that they did not want another store selling liquor. Mayor Ebinger said that Mr. More has been following all of the City's required ordinances and regulations for establishing his new business and that the City Council cannot take any action for or against the type of business that will be opening. After a lengthy discussion by the public and Mr. More, the Council took no action on the matter.
