Camy Rightmier and Tracie Lima from Siskiyou County Behavioral Health Services addressed the council on the many services they are providing Siskiyou County. They offer help to adults with severe mental health issues and to children who are emotionally disturbed. They provide help to those affected by drugs and alcohol addiction as well as counseling services and suicide prevention trainings. They help people with little to no insurance and they are working hard to bring these services to all the far corners of Siskiyou County. This was an informational presentation. No action taken.
