## COMMUNITY ORGANIZATIONS AND/OR TULELAKE BASIN JOINT UNIFIED SCHOOL DISTRICT UPDATE

No representatives were present at the meeting to give an update.

### <u>CITIZEN CONCERN REGARDING REPAIRS TO RENTAL PROPERTY LOCATED AT 464 FOURTH STREET</u>

This item was moved to later in the meeting when Stephanie Smith could be on the conference call. After Agenda item #11 was completed, the Council came back to this item. Stephanie Smith, representing the owner of the home, John R. Adair, Jr., had a complaint on how the city had acted towards the building inspection of the property located at 464 Fourth Street. There was discussion with various points of view on their differences between the Building Inspector, the Council and Ms. Smith. All parties came to the consensus of having the Building Inspector go back in to inspect for smoke and carbon monoxide detectors since they have a family living there. The Building Inspector stated upon the inspection he is obligated to write up anything that he deems as a danger based upon the building code. Ms. Smith is to make arrangements with the tenants for access to the home for the Building Inspector. No action taken.

# APPROVAL OF AGREEMENT WITH STATE WATER RESOURCES CONTROL BOARD FOR FUNDING FOR TULELAKE WATERLINE REPLACEMENT, METER REPLACEMENT AND BACKFLOW PROTECTION (PROJECT NO. 4710010-003P) IN THE AMOUNT OF \$123,000

Director of Public Works, Brett Nystrom, brought up to the Council the situation with the replacement of the need to install a backflow to protect the water system against any possible contamination along with new meters and pipe. Due to the importance to the City, this installation is very worthwhile. Mayor Ebinger made a motion to approve the Agreement with the State Water Resources Control Board for funding for Tulelake Waterline Replacement, Meter Replacement, and Backflow Protection, as well as, a change in dates in Item #2 to January 30, 2021 and February 28, 2021. Council Member Velador seconded the motion. Motion carried. (Motion 20-187).

### POSSIBLE APPROVAL OF MOVING THE FENCE ON MODOC AVENUE TO SEPARATE THE CITY OWNED LOTS FROM THE OLD TULELAKE POTATO BUILDING

The Director of Public Works, Brett Nystrom, presented to Council the issue of possibly moving the fence along the Union Pacific Railroad property to eliminate traffic from using the City lots as an access to the Union Pacific Railroad property. Brett said the Public Works Department would obtain the fencing materials and provide the labor to complete this project. Mayor Ebinger made a motion to approve moving the fence on the Modoc Avenue lots to separate the City owned lots from the Union Pacific Railroad property. Council Member Velador seconded the motion. Motion carried. (Motion 20-188).
