## Regular Meeting TULELAKE CITY COUNCIL

October 4, 2022 - 5:30 PM

Mayor Henry Ebinger called the meeting to order at 5:33PM. Mayor Pro Tem Penny Velador and Council Members Teresa Williams, Bryan Hendricks and Julia Pena Larsen were present. Also present was Chief of Police, Tony Ross; Finance Director, Will Sargent; City Hall Administrator, Jenny Coelho and City Administrative Clerk, Heidi Cureton. ### APPROVAL OF THE SEPTEMBER 20, 2022, REGULAR MEETING MINUTES

## APPROVAL TO ADVERTISE FOR PUBLIC COMMENT AND PUBLIC HEARING FOR THE PERMANENT LOCAL HOUSING ALLOCATION PROGRAM (PLHA) IN THE SISKIYOU DAILY NEWS

Jenny Coelho, City Hall Administrator, explained to Council of the need to advertise for public comment and the public hearing for the PLHA grant application in both the Siskiyou Daily News and on the City website. Mayor Ebinger made a motion to approve advertising in the Siskiyou Daily News and the City's website for public comments and the public hearing for the PLHA grant application. # APPROVAL OF THE 1<sup>ST</sup> ADDENDUM TO THE MEMORANDUM OF UNDERSTANDING & AGREEMENT BETWEEN TULELAKE AND SISKIYOU COUNTY SHERIFF'S OFFICE TO PROVIDE DISPATCH AND RECORDS SERVICES THROUGH JUNE 30, 2023 FOR THE CITY OF TULELAKE

Jenny Coelho, City Hall Administrator, told the Council that the Siskiyou County Sheriff's Office is doing a one-year addendum to the existing MOU that the City has with the Sheriff's Office to extend the dispatch and records services through 6/30/2023. Mayor Ebinger made a motion to approve the 1<sup>st</sup> Addendum to the MOU between Tulelake and the Siskiyou County Sheriff's Office. Council Member Hendricks seconded. Motion carried. ## APPROVAL TO REVISE THE FY22-23 POLICE PERSONNEL FUND (COPS GRANT) BUDGET TO INCLUDE THE FY21-22 GROWTH ALLOCATION IN THE AMOUNT OF \$65,271.25

Will Sargent, Finance Director, told the Council that he had estimated very closely in the budget for this growth allocation and that we were only off by approximately \$700 with revising for a budget decrease. Mayor Ebinger moved to approve revising the FY22-23 Police Personnel Fund (COPS Grant) budget to include the FY21-22 Growth Allocation in the amount of \$65,271.25. Mayor Pro Tem Velador seconded. Motion carried. (Motion 22-188)
