MINUTES Regular Meeting TULELAKE CITY COUNCIL March 19, 2024 - 5:30 PM

Mayor Tom Cordonier called the meeting to order at 5:39PM. Council Member Henry Ebinger was present. Council Member Bryan Hendricks was present via conference call. Also in attendance were City Treasurer, Sara Luscombe; City Clerk, Aissa Martinez; Chief of Police, Tom Hoy; City Hall Administrator, Jenny Coelho and Director of Public Works, Jose Perez. Those absent were Council Members, Teresa Williams and Julia Pena Larsen; Finance Director, Will Sargent; Chief Resilience Officer, Jose Fiscal; Police Officer, Brant Mauk and Assistant City Admin, Jazlyn Chavolla.

APPROVAL OF THE FEBRUARY 29, 2024, SPECIAL MEETING MINUTES

Mayor Cordonier made a motion to approve the February 29, 2024, special meeting minutes. Council Member Ebinger seconded the motion. All votes were aye. Motion carried. (Motion 24-56)

APPROVAL OF THE MARCH 05, 2024, REGULAR MEETING MINUTES

Council Member Ebinger made a motion to approve the March 05, 2024, regular meeting minutes. Mayor Cordonier seconded the motion. All votes were aye. Motion carried. (Motion 24-57)

APPROVAL OF THE PAYMENTS OF BILLS

COMMENTS FROM THE PUBLIC

Sara from the Tulelake Fire Department mentioned how bad the potholes are getting on Ray Oehlerich Way. Director of Public Works, Jose Perez, commented that the City is trying to get money through STIP to fix that road on a permanent basis and that for a temporary basis that the asphalt plant is not open yet to do patching. When the asphalt plant does open then the Public Works crew will be patching the potholes.

DISCUSSION AND APPROVAL FOR THE MAYOR TO SIGN THE PROCLAMATION FOR CHILD ABUSE PREVENTION MONTH IN APRIL AND HAVE THE CITY OF TULELAKE ADOPT THE PROCLAMATION MAKING A STANCE AGAINST CHILD ABUSE PREVENTION

DEPARTMENT HEAD UPDATES

Chief of Police: Tom Hoy commented that Police Officer, Brant Mauk, will be returning from K-9 training on Monday. He also commented that the bowling alley is falling, and he wrote a letter to the county hoping to get some assistance in demolishing the building.

Chief Resilience Officer: Absent.

City Hall Administrator: Jenny Coelho commented that the Kya group came down to follow up on how the proposed project at Otis Roper Park is progressing and if there is anything they can do to help. She mentioned that they will also be working with Chief Resilience Officer, Jose Fiscal, regarding the grant. They would like to have some feedback from the community on what they would like to see at Otis Roper Park so the Chief Resilience Officer may be attending community meetings to get feedback for the grant. Jenny also commented that the PSA was sent to the attorney for Bollard Acoustical. She stated that the RFP's were sent out for the architecture for the Cultural Visitors Center.

Director of Public Works: Jose Perez commented that Aldrich Construction will be starting work at Veterans park on Monday. He mentioned that the new guy he is hiring for seasonal work will be starting April 15th. He also mentioned that the burn pit is now open.
