City of Tulelake Snow Removal Policy

Date: November 4, 2025

Snow Removal

Snow removal operations will begin when a depth of **four inches** is measured at the intersection of Modoc Avenue and Main Street. This measurement will be conducted by the Director of Public Works or Public Works staff or as determined by the Tulelake Chief of Police. In the event a winter storm advisory is forecast by the National Weather Service, this site will be monitored on an hourly basis by Public Works staff.

Sidewalks

- The City is not responsible for the clearing of driveways or sidewalks other than those which front City- owned Facilities.
- Sidewalk clearing is up to the owner of residential and commercial properties, so if you have elderly or disabled neighbors, lend a hand!
- Please do not shovel or move snow from your property into the street.

Siskiyou County Road Department

Siskiyou County Road Department is responsible for snow removal on East West Road that goes through the City of Tulelake and on Main Street from G Street to Wright Road along with all other county roads that surround the City of Tulelake.

Caltrans

Caltrans is responsible for snow removal and sanding on California State Highway 139.

Parking

If there is a significant snow fall event expected the business owners, residents and patrons shall not park along Main Street or Modoc Avenue in order to allow snow removal equipment to plow, stock piling snow in center median of the streets and allowing snow removal for parking access. For residential snow removal streets, the City asks that residents please move cars to their residential driveways. For residents who do not have a driveway, the Public Works Department may post a notice on your residence door asking you to move your car to another location on a certain date and time while they proceed with snow removal from your street.

Street Posting Notifications

"The following streets are of insufficient width and parking is prohibited thereon during such snow conditions when the same are posted giving notice thereof:"

- · Ridgeview from Main Street to Dean Callas Way
- Dean Callas Way from Ridgeview to G Street
- G Street from Park Street to Dean Callas Way

- · C Street from Modoc Avenue to City Water Yard
- · Highway Street from First Street to Siskiyou Street

The Director of Public Works shall post the aforesaid streets in accordance with severity of snowfall accumulation.

Excessive Snowfall

In the event of excessive snowfall and any long-term power outage, 3 hours or longer, the Tulelake Library, Tulelake Fire Department and Tulelake City Hall shall be opened up for warming places if there is sufficient generator power for their operation.

Emergency Shelters

If there is a need for emergency shelters, arrangements will be made by the City of Tulelake and/or the Tulelake Multi- County Fire Department with various local entities that will be able to provide emergency shelter.

Driveways

Snow moved by snowplows may collect in front of or on driveways. This inconvenience is unfortunate, but unavoidable, as the City's Public Works Department is focused on making the streets safe and passable. The City does not clear private residential driveways. Please try to wait until after your street is plowed before removing snow from your driveway. Please note that your street may be plowed more than once, or not at all, depending on a number of different variables.

The City typically clears snow from the centerline of the residential streets to make it passable for drivers as soon as possible, with snowplows possibly returning to widen the cleared area. Please be aware this could increase snow buildup on or in front of your driveway.

Driveway Snow Removal Tip

If you clear the snow from your driveway before your street has been plowed, be sure to clear an area of snow to the right of the driveway (when you are facing the driveway from the street). This cleared area will allow most of the snow on the plow to be deposited before it gets to your driveway. The larger the area cleared the less snow will be moved in front of your driveway.

Snow Removal Order of Streets

View the order that the City generally removes snow from streets. This is subject to change depending on conditions and other circumstances. **The First Priority** is to provide access for essential emergency services of the City. The order of this work is to be as follows:

1. Ray Oehlerich Way from CA Hwy 139 to Dean Callas Way for Tulelake Multi- County

Fire Department

- 2. C Street from Modoc Avenue to Main Street for Tulelake Police Department
- 3. Main Street from Hwy 139 to G Street
- 4. Modoc Avenue from G Street through Main Street Intersection
- 5. Wastewater Treatment Plant and Water Treatment Facilities as required

The remainder of the City is to be plowed and/or sanded in the second and third priority order.

The Second Priority is to provide access to the Tulelake Elementary, Tulelake High School and Tulelake Butte Valley Fairgrounds.

- 1. B Street from Second Street to Main Street
- 2. Second Street from B to East West Rd
- 3. C Street from Water Yard to Main Street
- 4. D Street from Second Street to Main Street
- 5. G Street from Dean Callas Way to Park Street

The Third Priority is to provide snow removal for all residential and multi-family housing streets. This can be done in any order that the Director of Public Works or Chief of Police believes is necessary. This snow removal can be done in four quadrants for the Northeast, Northwest, Southeast and Southwest portions of the City.
