#### APPROVAL OF THE JUNE 19, 2018 SPECIAL MEETING AND REGULAR MEETING MINUTES

#### APPROVAL OF BILLS

## PUBLIC MEETING: TO CONSIDER AN ORDINANCE APPROVING THE PROPOSED SALE OF THE FEE INTEREST IN THE LAND UNDERLYING THE TULELAKE MUNICIPAL AIRPORT, LOCATED IN THE COUNTY OF MODOC, APNS: 005-210-009 AND 005-220-020

Mayor Ebinger asked the public if they had any comments concerning the proposed sale of the fee interest in the land underlying the Tulelake Municipal Airport. Mayor Ebinger made a motion for the Department Heads and City Police Officers to be responsible for serving the administrative citations from their various departments. Council Member Velador seconded. Motion carried. (Motion 18-112)

### ADDRESS A SUITABLE WAY FOR DEPARTMENT HEADS TO COMMUNICATE WHAT VENDOR INVOICES AND RECEIPTS ARE AND HOW THEY SHOULD BE CODED TO INSURE PROPER BILLING ENSUES.

Mayor Ebinger made a motion to have the City Administrative Clerk design a form for the Department Heads to complete and turn in with their invoices and receipts. Council Member Nicholson seconded. Motion carried. (Motion 18-113)

#### APPROVAL OF RESOLUTION 18-11 ESTABLISHING A LIEN AGAINST A CERTAIN REAL PROPERTY, LOCATED AT 347 MODOC AVENUE, TULELAKE, PURSUANT TO TULELAKE RESOLUTION 14-04

Mayor Ebinger made a motion to approve Resolution 18-11 establishing a lien on the property located at 347 Modoc Avenue, Tulelake, California. Council Member Velador seconded. Motion carried. (Motion 18-115)

#### APPROVAL TO HIRE A TEMPORARY/PART-TIME BUILDING INSPECTOR UNTIL A FULL TIME INSPECTOR CAN BE HIRED

Mayor Ebinger made a motion to continue the agreement with the City of Weed and their hiring of a temporary building inspector who would continue to do inspections for Dorris and Tulelake, until a full time inspector is hired by the City of Weed. Council Member Velador seconded. Motion carried. (Motion 18-116)
