## APPROVAL TO SEEK FUNDING FOR THE VETERANS PARK EXPANSION PROJECT SHORTAGE IN ORDER TO GET THE PROJECT STARTED

Director of Public Works, Brett Nystrom, informed the Council about the great progress that has been made in lowering the construction cost of the project from the original \$392,000 bid to now approximately \$359,000. The majority of the savings came from the donation of fill dirt from the local farmers. He mentioned that even with that donation the City is still responsible for ordering and installing the solar lights and the gazebo. There is still a shortfall of approximately \$53,000 for the project and is asking if the Council would approve a loan if necessary to complete the project. The Council said they would approve obtaining a loan along with doing City fundraisers to raise funding for the shortfall. The Mayor made a motion to approve applying for a loan for the Veterans Park Expansion Project shortfall in funding contingent upon the Finance Director's approval. Mayor Pro Tem Marcillac seconded the motion. Motion carried. (Motion 20-163)

#### APPROVE OF THE PROPOSED VALUED ENGINEERING CONTRACT

The Council tabled this item until the engineer can present the new valued engineering contract.

#### PERMISSION TO ADVERTISE FOR THE TEMPORARY CITY STAFF/LIBRARY POSITION

Council Member Fensler made a motion to advertise for the Temporary City Staff/Library position. Mayor Pro Tem Marcillac seconded. Motion carried. (Motion 20-164)
