Mayor Ebinger, being happy with the hard work from the Public Works Director and City Hall Administrator, made a motion to approve the Notice of Award to Modoc Contracting, Inc. as a general contractor for the Veterans Park Expansion project administered by Adkins Consulting Engineering, LLP. The motion was seconded by Mayor Pro Tem Marcillac. Motion carried. (Motion 20-171)

# REVIEW AND APPROVE LOW BIDS FROM UNITED MECHANICAL CONTRACTORS INC., FOR \$7,317 FOR THE HEATING AND COOLING UNIT FOR THE WASTEWATER TREATMENT PLANT OFFICE. RECEIVED ONLY TWO BIDS FROM CALIFORNIA LICENSED CONTRACTORS FOR THIS INSTALLATION

Brett Nystrom, Public Works Director, came to the City Council seeking an approval to accept the low bid from United Mechanical Contractors Inc. of \$7,317 for replacing the current heating and cooling unit at the Wastewater Treatment Plant office. City Hall Administrator, Jenny Coelho, recommended that adding a drop ceiling would also improve the effectiveness of a new heating/cooling unit and suggested that one should be considered. United Mechanical Contractors already had this in their bid for an additional \$5,815. Mayor Ebinger made a motion to approve the low bids from United Mechanical Contractors Inc. for \$7,317 for the heating and cooling unit along with the installation of a drop ceiling for the additional \$5,815. The motion was seconded by Mayor Pro Tem Marcillac. Motion carried. (Motion 20-172)

#### POSSIBLE APPROVAL TO SUBMIT APPLICATION FOR THE BROWNFIELD MULTI-PURPOSE GRANT FOR DEMOLITION OF THE CLYDE HOTEL PROPERTY LOCATED AT 305, 309, 311, & 315 MAIN STREET, APN 050-053-010-000

City Hall Administrator explained to Council that a grant was available that would help the city pay for the demolition of the Clyde Hotel and asked for approval to apply. Mayor Ebinger made a motion to submit an application for the Brownfield Multi-Purpose Grant for demolition of the Clyde Hotel property located at 305, 309, 311, and 315 Main Street, APN 050-053-010-000. The motion was seconded by Council Member Velador. Motion carried. (Motion 20-173)

# PERMISSION TO PROCEED WITH PROCESS FOR THE CITY TO OBTAIN LEGAL OWNERSHIP OF THE CLYDE HOTEL PROPERTY LOCATED AT 305, 309, 311, & 315 MAIN STREET, APN 050-053-010-000

City Hall Administrator clarified to Council that in order for the City to apply for the Brownfield Multi-Purpose Grant, they would need to obtain legal ownership of the building. Mayor Ebinger, taking into consideration the limited time to apply and obtain ownership, made a motion to proceed with the process for the City to obtain legal ownership of the Clyde Hotel property located at 305, 309, 311, and 315 Main Street, APN 050-053-010-000. The motion was seconded by Council Member Velador. Motion carried. (Motion 20-174)
