December 20, 2022 - 5:30 PM

Mayor Penny Velador called the meeting to order at 5:31PM. Council Members, Teresa Williams and Bryan Hendricks were present. Mayor Pro Tem, Tom Cordonier was present via conference call. Council Member Julia Pena Larsen arrived at 5:49PM. Also present were City Treasurer, Sara Luscombe; City Clerk, Aissa Martinez; Chief of Police, Tony Ross; Assistant Chief of Police, Tom Hoy; Finance Director, Will Sargent; City Hall Administrator, Jenny Coelho; City Administrative Clerk, Heidi Cureton and Director of Public Works, Jose Perez.

APPROVAL OF THE DECEMBER 06, 2022, REGULAR MEETING MINUTES

Council Member Hendricks made a motion to approve the minutes of December 06, 2022. Council Member Williams seconded. All votes were aye. Motion carried. (Motion 22-236)

INTRODUCTION OF ORDINANCE 22-103 ADDING CHAPTER 15.10, ELECTRIC VEHICLE CHARGING STATIONS, AND CHAPTER 15.12, HEARING AND APPEALS, TO TITLE 15, BUILDINGS AND CONSTRUCTION, OF THE TULELAKE MUNICIPAL CODE

Mayor Velador moved to make the finding that it can be seen with certainty the project will not have a significant adverse impact on the environment and is CEQA exempt pursuant to CEQA Guidelines Section 15061(b)(3). Council Member Williams seconded the motion. All votes were aye. Motion carried. (Motion 22-240)

Mayor Velador made a motion to introduce and read Ordinance 22-103 by title only and directed staff to bring Ordinance 22-103 back for adoption at the next regular City Council meeting. Council Member Williams seconded the motion. All votes were aye. Motion carried. (Motion 22-241)

APPROVAL OF REMOVING HENRY EBINGER AS A CHECK SIGNER ON ALL UMPQUA BANK ACCOUNTS

Mayor Velador made a motion to remove Henry Ebinger as a check signer on all Umpqua Bank accounts. Council Member Hendricks seconded the motion. All votes were aye. Motion carried. (Motion 22-242)

UPDATE AND POSSIBLE APPROVAL OF BIDS ON THE THEATER WALL

Mayor Velador made a motion to table the possible approval of bids on the theater wall because they are still waiting for one additional bid. Council Member Pena Larsen seconded the motion. All votes were aye. Motion carried. (Motion 22-243)

APPROVAL TO REGISTER COUNCIL FOR THE COUNCIL MEMBERS ACADEMY FOR JANUARY 18-20, 2023, FOR ALL CITY COUNCIL MEMBERS TO FOLLOW RESOLUTION 22-11, WHICH WAS PASSED ON JUNE 07, 2022, ENCOURAGING TRAINING FOR ALL NEWLY ELECTED AND VETERAN COUNCIL MEMBERS

Mayor Velador made a motion to register all interested Council Members for the training academy. Since some are unable to attend this year, it was suggested that Council Members alternate each year, so everyone has an opportunity to attend. Council Member Pena Larsen seconded the motion. All votes were aye. Motion carried. (Motion 22-244)

APPROVAL OF THE FY22/23 SALARY SCHEDULE FOR THE CITY OF TULELAKE

City Finance Director, Will Sargent, explained that the California minimum wage was increasing to \$15.50 beginning January 01, 2023, and has been increasing by \$1 per hour for the past five years but the middle tier base wages were never bumped up. The minimum wage would now be more than the middle tier base wage, so in fairness, it needed to be addressed. Council Member Williams expressed a desire to look more carefully at the salary schedule and believes that the Police Department and Public Works employee wages need to be higher. Will suggested they have the workshop sometime in January before tax season begins, so he could attend. Mayor Velador made a motion to approve the FY22/23 salary schedule for the City of Tulelake. Council Member Hendricks seconded the motion. All votes were aye. Motion carried. (Motion 22-245)

APPROVAL OF \$3.00 PER HOUR RAISE TO EXEMPT EMPLOYEES, JOSE PEREZ AND JENNY COELHO, FROM \$28.00 PER HOUR TO \$31.00 PER HOUR TO FOLLOW CALIFORNIA RULES OF PAYING A SALARY THAT IS AT LEAST TWICE THE STATE'S CURRENT MINIMUM WAGE OF \$15.50 PER HOUR, EFFECTIVE FOR THE JANUARY 06, 2023, PAYROLL

Mayor Velador made a motion to approve the \$3.00 per hour raise to exempt employees, Jose Perez and Jenny Coelho, effective for pay period ending December 31, 2022. Council Member Hendricks seconded the motion. All votes were aye. Motion carried. (Motion 22-246)

Department Head, Jose Perez made the above recommendations for raises for the Public Works Crew. Mayor Velador made a motion to approve the recommended performance raises for Public Works Employees as listed above, effective for pay period ending December 31, 2022. Council Member Pena Larsen seconded the motion. All votes were aye. Motion carried. (Motion 22-247)

Department Head, Jenny Coelho made the recommendations for raises as listed above. Mayor Velador made a motion to approve the recommended performance raises for City Hall Staff, Library Branch Manager and City Custodian. Council Member Hendricks seconded the motion. All votes were aye. Motion carried. (Motion 22-248)

REQUEST TO GET A SEPARATE CREDIT CARD FOR THE PUBLIC WORKS DEPARTMENT USING THE CITY HALL CAPITAL ONE SPARK BUSINESS MASTER CARD ACCOUNT

Finance Director, Will Sargent, stated that it made sense for the Director of Public works to have a credit card to use for emergency purchases. The City would not be opening another account, just getting a card on the City Hall account with the name of the Public Works Director one a card for his use. Mayor Velador made a motion to approve getting a credit card for the Public Works Department. Council Member Williams seconded the motion. All votes were aye. Motion carried. (Motion 22-249)

DEPARTMENT HEAD UPDATES:

Assistant Chief of Police: Tom Hoy stated that K-9 training was going very well. Also, he did not get the K-9 vehicle from Malin, Oregon he was hoping for, so he has been busy getting all the K-9 equipment taken out of the Malin vehicle and putting it in the Tulelake Tahoe. He is, however, getting a free Charger from Malin which, he is excited about. He would rather save his budget and not have to buy a new car.

City Hall Administrator: Jenny Coelho announced that the next meeting for SCORE is January 27, 2023, in Anderson, CA. She also thanked everyone for coming to the Christmas party. She is hoping to know more on the Jumpstart grant by January or February. They should be finished up on the Clyde grant by March 2023. She mentioned she had feelers out on Cultural Center funding and W2's and 1099's will be out by January 31, 2023.

Director of Public Works: Jose Perez wanted to thank Council Member Hendricks for letting him borrow his trailer to pick up the dumpsters that were bought for the City in Galt, CA. He announced that the ten samples he sent in for water testing came back good with the conclusion that there is no problem with the City water. Any customers having issues may need to check their own plumbing lines.

Finance Director: Will Sargent announced that Charlie is getting ready to wrap up the audit. He is hoping to get results back in January, if not, February.
